The 18<sup>th</sup> Meeting of the Academic Council of Islamiah College [Autonomous], Vaniyambadi was held on 09-10-2023 at 11-30 a.m. through blended mode. The meeting commenced with prayer by **Mr. P. Tanveer Ahmed**, Head, Department of Urdu & Arabic.

The Secretary and Correspondent of Islamiah College [Autonomous], Vaniyambadi, **Mr. L. M. Muneer Ahmed**, welcomed the members of the Academic Council and thanked all the stakeholders of the College for getting the extension of Autonomy status to the college for another 10 years till 2031-2032. He brought to the knowledge of members, that the college has received Green Champion Award with a cash prize of Rupees one Lakh from Tamilnadu Pollution Control Board, Chennai which handed over to the College by the Tirupattur District Collector. He further lauded the efforts of IQAC in organising various programmes and congratulated the staff members involved in getting two patents to our college. He commended the efforts of the Examination Cell for the smooth functioning of examination and evaluation works, especially the fair evaluation and timely publication of results.

**Dr. T. Mohamed Ilyas**, chairman, of the meeting, read the minutes of the 17<sup>th</sup> Academic Council Meeting which were approved by the house.

**Dr. T. Afsar Basha**, Vice-Principal, IQAC Coordinator, moved the Regulations and Schemes of Examinations for UG & PG programmes for the semester I & II as given in Regulations and Schemes - Volume XVII for UG & PG Students admitted from the Academic year 2023-2024 and the Revised Course Structure volume XVI [Annexure I]

for B.Com., B.C.A., B.B.A., B.Com. [C.A.], B.Com. [F & A] students admitted in the Academic year 2022-2023 and it was resolved to ratify and approve the same.

**Dr. J. Srinivasan**, External Expert, praised the college for adopting the TANSCHÉ model regulation for the benefit of students. He further enquired about the Allied Chemistry Practical course offered for B.Sc. Biochemistry students. **Dr. F. Liakath Ali Khan**, Dean, Examinations replied that the course is aimed at acquainting the students of B.Sc. Biochemistry with Experimental knowledge of Chemistry.

**Dr. G. Yoganandham**, University Nominee, enquired whether the course 'E-Filing of Returns' is a core course or Skill Enhancement course, to which **Dr. S. Liyahath John**, Head of Department of Commerce (Finance & Accounts) replied that, it is a Skill Enhancement course, since the course imparts practical knowledge and develops employability and skills.

**Dr. M. Chitra**, University Nominee, suggested to include a course on Business Mathematics to the BBA Degree Programme, to which **Dr. J. Srinivasan**, External member, replied that a course on Business Statistics is already present in BBA and adding Business Mathematics would limit the hours available for teaching core courses and it was accepted by all members.

Chairman, Board of Studies of all the Departments moved the Syllabi for I & II Semesters of all UG & PG Programmes for students admitted from Academic Year 2023-2024 and the revised Syllabi for Semesters III & IV of B.Com., B.C.A., B.B.A., B.Com. [C.A.], B.Com. [F & A] for students admitted during the Academic Year 2022-2023 and it was resolved to ratify and approve the same unanimously.

**Dr. K. Anandaratchagan**, Head of Department of Chemistry, moved the resolution for ratification and approval of an additional Value-added Certificate Course "UV Visible & IR Instrumentation Technique" conducted by the PG & Research Department of Chemistry from the academic year 2023-2024 and the same was approved by the council.


**Mr. S. Mohammed Naseeruddeen**, Controller of Examinations, moved that the Examination Manual Vol. XVI, be adopted for implementation from November 2023 Odd Semester Examination which was unanimously approved by all members.


**Dr. B. Kathiresan**, External Expert, asked if the system of providing dummy numbers to the answer scripts is still being followed, to which **Dr. F. Liakath Ali Khan**, Dean, Examinations replied that random Dummy Numbers are generated digitally to ensure confidentiality in the Examination Evaluation process.

**Mr. S. Mohammed Naseeruddeen**, Controller of Examinations, placed the results of the Autonomous Even Semester Examinations held in April / May 2023 for ratification and it was resolved to ratify and approve and ratify the same by the august House.

In any other academic matter, **Dr. A. Sait Sahul Hameed**, appreciated the college for getting two new patents, and suggested that, teachers should not stop with patents and try to create a prototype and market it by forming linkages with Industry and other Institutions. He further suggested that all teachers and especially those undertaking Projects should be trained in PFMS to understand its functionality, to which **Dr. T. Mohamed Ilyas**, Chairman replied that the college is already using PFMS for transacting UGC, NSS and other funds, and the staff involved are well versed with the system.

The meeting came to an end at 1.00 p.m. with a formal vote of thanks by the Member Secretary **Dr. Syed Tahir Hussainy**. The Secretary & Correspondent and Principal requested all the members to give their company in the delicious lunch.
