- 1. The Principal [i/c] & Chairman read out the Minutes of the previous Finance Committee Meeting held on Tuesday 2<sup>nd</sup> May 2023, and was approved by the members.
- 2. Resolved to approve the Revised Examination Fee Structure and Revised Examination Remuneration (as per the List enclosed), from Odd Semester 2023 2024, at par with Thiruvalluvar University, Vellore, with the exception of fees for few heads, which were decided to be kept lower than the Thiruvalluvar University, Vellore, considering the rural background and financial difficulties of students.

- 3. Resolved to approve the revised budget for the Odd Semester Autonomous Examinations Nov./Dec. 2023 and Even End Semester Autonomous Examinations April/May 2024.
- 4. Further resolved to recommend the Governing Body for approval of the above-said resolutions passed by the 22<sup>nd</sup> Finance Committee.
