MINUTES OF THE FOURTH MEETING OF THE ACADEMIC COUNCIL HELD ON 31-03-2013

The Fourth Meeting of the Academic Council of Islamiah College (Autonomous) was held on 31-03-2013 at the Multimedia Hall. The meeting commenced at 11.00 A.M with prayer by Prof. P.R Md. Saifullah. Dr. K. Prem Nazeer, Principal, welcomed the gathering.

In the business brought forwarded by the Chairman, the Minutes of the Third Meeting of the Academic Council were read by the Chairman and the house approved it.

Dr. Major Syed Shahabuddeen, Governing Body Nominee, moved the U.G. and P.G. Regulations and the Schemes of Examinations for various courses to be implemented from the academic year 2013-14 were unanimously approved by the Council.

Chairmen, Boards of Studies of various Departments, moved their Resolutions, as per the agenda, regarding the approval of the Syllabi of their respective Departments for I and II Semesters of various U.G. and P.G. courses with effect from the academic year 2013-14. All the Resolutions were adopted.

Dr. H. Nisar Ahmed, Controller of Examinations-in-charge, moved the Resolution for implementing the Examination Manual Volume II from the academic year 2013-14 and it was adopted by the Council.

He also moved the Resolution for ratifying the results published for the I, III and V^{th} Semesters.

Some members of the Academic Council brought forwarded the Resolutions. They were discussed in the council and passed the following Resolutions:

Prof. P. Tanveer Ahmed, a member of the Academic Council, requested the Council to introduce a Certificate Course in Arabic for the students and staff members as a Self-Supporting programme to be implemented from the next academic year 2013-14. The Council unanimously passed the Resolution and approved it.

Dr. G. Md. Hussain-us-Zaman, a member of Academic Council, requested to introduce a Certificate Course in Ornamental Fish Keeping under the Extension Activity Programme to be implemented from the next academic year 2013-14. The Council unanimously approved it.

Dr. F. Liakath Ali Khan, a member of the Academic Council, requested the body to increase the examination fees for arrear papers to minimize and discourage the arrear students to be implemented from the next academic year 2013-14. The Council dropped it.

The Resolutions of Dr. M. Basha, a member of the Academic Council, to have the question paper pattern in accordance with NET/SLET Examination and to have more optional papers in the elective subjects were dropped due to his absence.

Dr. U. Rizwan, a member of the Academic Council, requested the Council to set up a Question Paper Scrutiny Committee before the conduct of the End Semester Examinations. The house unanimously dropped this since this has been already included in the Examination Manual Vol. II.

The other request of Dr. Rizwan to prepare the Scheme of Valuation by the Departments concerned was also dropped. It was unanimously approved that the Scheme of Valuation shall be prepared by the Question Paper Setters concerned.

Dr. Rizwan also requested the Council to sanction funds for the publication of books by the Departments concerned. It was unanimously approved to recommend and forward the matter to the Finance Committee of the College.

In any other matter, no transaction took place.

The meeting came to an end at 12.15 p.m. with a formal Vote of Thanks by the Member Secretary, Dr. F. Liakath Ali Khan.
