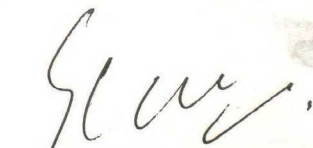

THE FINANCE COMMITTEE PASSED THE FOLLOWING RESOLUTIONS UNANIMOUSLY

1. Chairman of the meeting read out the Minutes of the 24th Finance Committee Meeting held on 24th April 2025, and was approved by the members.
2. Resolved to approve the expenditure for UGC Autonomous Grants for the year 2025-2026. The Principal & Chairman, brought to the attention of all members that UGC has not provided funds towards Autonomous Grants, the management has been kind enough to extend the advance money.
3. Resolved to approve the budget for Autonomous Grants to be received from UGC for the year 2026-2027.
4. Resolved to approve the Statement of Accounts of the Examination Cell for the year ending 31 March 2026.
5. Resolved to approve the Budget of Examination Cell for the year 2026-2027.
6. Resolved to approve the utilisation of Surplus Examination funds Rs. 56,00,000 for the Infrastructural Development of the College.
7. Resolved to approve the enhancement of fee and remuneration for following:
 - i. General (Seating) Arrangements at Re. 1 per student (one claim during the entire period of exam based on maximum number of students attending any one of the sessions)
 - ii. Processing Dummy Numbers for Evaluation at Re. 0.20 per answer script
 - iii. Time Keeping Staff at Rs. 500 for the entire examination
 - iv. Enhancement of Remuneration to Hall Superintendent from Rs. 175 to Rs. 200
 - v. Enhancement of maximum limit of typists from 2 to 3 per exam session
 - vi. Enhancement of exam fee per Theory/Practical course (subject) to Rs. 800 for students appearing in Examinations after 5 years of their admission in to the programme.
8. Further resolved to recommend the Governing Body for approval of the above said resolutions passed by the 25th Finance Committee.

The meeting came to an end at 4-30 p.m. with a formal vote of thanks by Dr. S. Shaik Khader Nawaz.

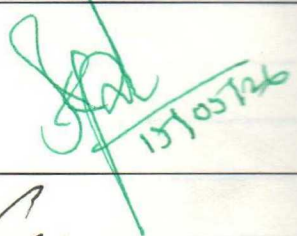
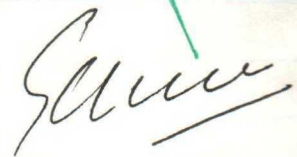
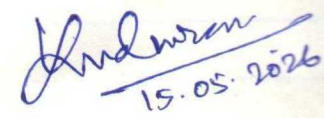
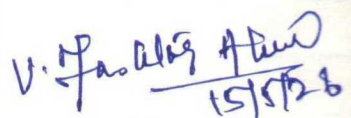
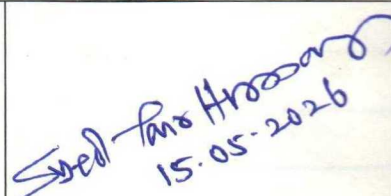
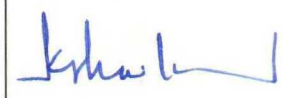
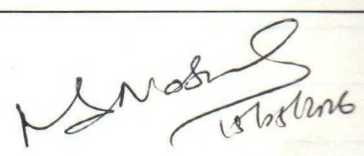
