30th June 2021

The 14th Academic Council Meeting of Islamiah College [Autonomous], Vaniyambadi was held on 30-06-2021 at 11-30 a.m. in a blended mode in-view of the second COVID-19 wave. The meeting commenced with prayer by Mr. P. Tanveer Ahmed, Head, Department of Urdu & Arabic.

The Secretary and Correspondent of Islamiah College [Autonomous], **Mr. L. M. Muneer Ahmed** welcomed the members of Academic Council and elaborated the growth and development of the College over the period of 11 years of Autonomy [2010-2021] and the NAAC Peer Team visit of our college on 27th & 28th January 2021. The team admired the infrastructure facilities in the campus and acclaimed digital technology available in the COE office and Library and appreciated the contribution of the stakeholders of this College. The College has obtained 'A' Grade in 3rd cycle of NAAC accreditation. He expressed two years of COVID pandemic period could not make much impact on the normal functioning as the teachers and students were actively involved in online classes. He appreciated several programmes conducted by the IQAC such as NET/SET coaching classes for the students and Research Scholars. He also insisted to face the extension of Autonomy committee with high morale and confidence. He admired the department of Examinations conducted online exams during the pandemic period, completion of paper evaluation and timely issue of Grade cards & Consolidated Marks statement to the final year UG & PG students. He congratulated the COE, Dr. F. Liakath Ali Khan for burning his midnight oil to complete this daunting task.

The Principal & Chairman has read out the Minutes of the previous Academic Council Meeting held on 7th October 2020, which has been approved by the august house unanimously.

Dr. S. Raja Mohamed Kamil, Vice-principal & Head of the Department of Chemistry, moved the "Regulations and Schemes of Examinations" for various UG & PG programmes for semester III & IV as given in Regulations and Schemes - Vol. XIII and it was resolved to approve the same with effect from the academic year 2021-2022 and thereafter.

Chairman, Board of Studies of all the Departments moved the Syllabi for III & IV Semesters of UG and PG Programmes and it was resolved to approve the same unanimously.

Dr. Syed Tahir Hussainy moved the revised procedure for the award of Internal & External Marks for Extension activities to all UG Programmes as Internal 25 Marks for Activities inside the College campus & External: 75 Marks for Activities Outside the College campus from the academic year 2020-21 and it was resolved to ratify and approve the same unanimously.

Dr. J. Srinivasan, Associate Professor of Commerce, Rajeswari Vedachalam Govt. Arts College, Chengalpattu, sought clarification in page no 39 of Regulations & Schemes -Vol. XIII from the chairman whether the course title in semester III & IV of Physics Programme is "Allied Mathematical Statistical Practical" or "Allied Mathematical Statistics Practical". It was rectified by Chairman and Dr. Syed Tahir Hussainy, Associate Professor of Mathematics, course titled as "Allied Mathematical Statistics Practical".

Dr. J. Srinivasan wanted to clarify the submission of Project for the UG/PG degree programme as an independent or a group. The chairman replied to the query that the Apprenticeship / Internship/Project were allowed to submit individual or in a group with maximum of FIVE students for UG Programmes.

Dr. A. Sait Sahul Hameed, Co-Chairman, DBT, New Delhi and Director of Aquatic Animal Health Laboratory, C. Abdul Hakeem College, Melvisharam has asked about the PG project work and Dr. A. Liyakath Ali, Head, department of Biochemistry has clarified that PG Programme has individual project work.

Dr. J. Srinivasan has raised a doubt about the instant examination for final year UG/PG students and it was clarified by COE, Dr. F. Liakath Ali Khan that student with only one arrear paper can appear for instant Examination irrespective of semester for both UG/PG programmes. He appreciated the positive impact of Examination Reforms and Grievances Redressal Mechanism of COE office. He also acknowledged the usage of library by UG, PG & M.Phil students.

Dr. J. Srinivasan appreciated the Certificate Courses offered by the various department and also recommended that 40% of MOOC/SWAYAM courses to be implemented as credit courses. The Chairman replied the MOOC/SWAYAM courses already implemented and our students and faculty members are benefited

Dr. A. Sait Sahul Hameed recommended the report on Research activities and Major & Minor Projects are to be incorporated in the "Regulation & Schemes of Examinations". The Chairman welcomed his recommendations and agreed to follow from the next Academic Council Meeting.



Dr. F. Liyakath Ali Khan, Controller of Examinations, moved the Examination Manual Vol. XII for implementation from 2021 -2022 Odd/Even Semester Examinations and the august body has approved it.

Liyakath Ali Khan, Controller of Examinations, placed the results of the Online Even Semester Examinations held during May 2020, Online Odd Semesters Examinations held during November 2020 and Online Even Semester Examinations held during May 2021 for ratification and it was resolved to ratify and approve the same by the august House.

In any other academic matter, the Chairman has informed the august house about the UGC letter dt. 15th April 2021 regarding the inclusion of NCC Credit Course to all UG Programmes as a part of NEW Education Policy. As the TANSCH/ Thiruvalluvar University are yet to give their directions and hence the NCC Credit Course will be adopted in future accordingly.

The meeting came to an end at 1.10 p.m. with formal vote of thanks by the Member Secretary and Controller of Examinations Dr. F. Liyakath Ali Khan. The Secretary & Correspondent and Principal requested all the members to give their company in the delicious lunch.

28th February 2022

The 15th Academic Council Meeting of Islamiah College [Autonomous], Vaniyambadi was held on 28-02-2022 at 11-30 a.m. through blended mode. The meeting commenced with prayer by Mr. P. Tanveer Ahmed, Head, Department of Urdu & Arabic.

The Secretary and Correspondent of Islamiah College [Autonomous], Vaniyambadi, **Mr. L.M. Muneer Ahmed**, welcomed the members of the Academic Council and elaborated the growth and development of the College during 2021-2022 such as increased ICT enabled classrooms, the establishment of a Virtual Library and the ongoing construction of Gymnasium. He further appreciated the efforts of IQAC in conducting various programmes for the enhancement of the quality, such as the NAAC sponsored "Enhancing and Sustaining Quality in Higher Educational Institutions through new Accreditation Framework of NAAC" and Orientation Programme on "Publishing Research in Peer Reviewed Journals – A right approach". He has also appreciated the College for having applied for NIRF on 02-02-2022 and also uploaded the AQAR. He commended the efforts of the office of COE for the smooth functioning of examination related works, especially the fair evaluation and timely publication of results. He stated that the morale is high for the upcoming Autonomy review.

The chairman of the meeting read the minutes of the 14th Academic Council Meeting and was approved by the house.

Dr. S. Raja Mohamed Kamil, Vice-principal & Head of the Department of Chemistry, moved the Regulations and Schemes of Examinations for various UG programmes for Semester V & VI as given in Regulations and Schemes - Vol. XIV and it was resolved to approve the same with effect from the academic year 2022-2023 and thereafter.

Dr. C. Dhandapani, University Representative raised a query with regard to the total number of credits for UG programme as being 180 as opposed to 150 in the Thiruvalluvar University. **Dr. F. Liakath Ali Khan**, Member Secretary Clarified that the 30 additional credits are given for the Apprenticeship / Internship / Project, introduced in the VI Semester as per the guidelines of UGC.

Dr. S. Major Syed Shahabuddeen, External Expert, asked about any remarkable change in the proposed structure to which **Dr. F. Liakath Ali Khan**, Member Secretary clarified that Core-based Electives and Skill-based Electives have been introduced in the V and VI Semesters of all UG Degree programmes.

Dr. C. Dhandapani, University Representative, suggested to consider changing the question paper pattern for PG degree programmes to include two marks questions, as introduced in Thiruvalluvar University Department. **Dr. F. Liakath Ali Khan**, Member Secretary and Controller of Examinations responded that it will be considered in the next regulation.

Chairman, Board of Studies of all the Departments moved the Syllabi for V & VI Semesters of UG Programmes and it was resolved to approve the same unanimously.

Dr. A. Mohamed Ali, Associate professor of Mathematics, moved that a MOOC of a minimum of 4 weeks duration is mandatory for M.Phil. Scholars admitted from the academic year 2021-2022. The certificate of completion of MOOC is to be enclosed along with the dissertation at the time of its submission and it was approved by the members.

Dr. N. Abdul Latheef, the Librarian, moved the guidelines for the award of marks for Library usage for UG, PG and M.Phil. Degree programmes in the Internal Marks component from the academic year 2021-2022 onwards as given below, and it was ratified and approved by the members.

Dr. C. Dhandapani, University Representative, enquired whether these library usage hours are included or excluded from the class hours, to which the chairman replied that they are exclusive of the class hours.

Dr. S. Tahir Hussainy, Associate Professor of Mathematics, moved that a MOOC of a minimum of 4 weeks duration is mandatory for all students of UG and PG degree programmes admitted from the academic year 2022-2023. One additional credit shall be given for this MOOC and shall be included in the CGPA.

Dr. J. Srinivasan, External Expert, sought clarification with regard to whether the MOOC should be from the discipline of the student or from a General topic. The Chairman clarified that the student can undergo MOOC from any discipline of his choice.

Dr. C. Dhandapani, University Representative, expressed his concerns with regard to the student's ability to register and complete the course. The chairman assured the members that the college has appointed a SWAYAM MOOC course coordinator who shall be assisting the students in the registration procedure. Further, he stated that the students can utilise the Virtual Library for the completion of their course.

Dr. F. Liakath Ali Khan, Controller of Examinations, moved that the Examination Manual Vol. XIII be adopted for implementation from February 2022 Odd Semester Examination which was unanimously approved and ratified by the members.

Dr. F. Liakath Ali Khan, Controller of Examinations, placed the results of the Autonomous Odd Semester Examinations February 2022 for ratification and it was resolved to approve and ratify the same by the august House.

Dr. F. Liakath Ali Khan, Controller of Examinations, brought forth the guidelines for redo category students regarding their Internal Marks and Marks secured in Practical Examinations. Dr. M. N. Arumugham, University Representative, suggested that redo students who have already completed their CIA Test and Practical Examination with at least minimum qualifying marks may be exempted from reappearing the CIA Test and Practical Examination again in the readmitted Semester. However, if any student wishes to improve upon his marks, he can appear for the CIA Test and Practical Examinations. In such a case, the original marks or the marks secured in the readmitted semester, whichever is higher, shall be taken as final marks.

In any other academic matter, the Chairman brought to notice, the requisition placed by Dr. H. Abdul Jaffar Ali and Prof. K. Manzoor Ahmed which has been recommended by the standing committee for discussion in the AC Meeting and it was placed in the august house,

Dr. H. Abdul Jafar Ali, Head, Department of Bio-Technology, proposed the introduction of a three-month Value Added Certificate Course in Ornamental Fish Culture to be offered to UG students from the academic year 2022-2023. Dr. A. Sait Sahul Hameed, External Expert, lauded this effort and remarked that this certificate course has high significance in developing entrepreneurship amongst the students. Dr. M. N. Arumugham, University Nominee questioned whether it would involve a field visit. Dr. H. Abdul Jafar Ali, assured that the course would comprise of hands-on training at the College, field trips and focussed more on experiential learning. The august house has unanimously approved the same.

Prof. K. Manzoor Ahmed, Head, Dept. of Business Administration, moved that the Fifteen courses across B.Com. Commerce, B.Com. Finance & Accounts, B.Com. Computer Applications, Business Administration and two courses across B.Com. Commerce, B.Com. Finance & Accounts, B.Com. Computer Applications, be considered for having common syllabi for the students admitted from the academic year 2022-2023. Dr. J. Srinivasan, External Expert, appreciated this effort. The chairman suggested that the syllabi for these courses be placed before the next Board of Studies of the concerned departments for approval. Dr. Major Syed Shahabuddeen, External


Expert suggested that due weightage shall be given to their respective Major specialised subjects such as Computer Application course for B.Com. [C.A.] and Finance /Accounting related courses for B.Com. [F.A.]


Dr. J. Srinivasan, External Expert, commended the steps taken by the College in its 12 years of Autonomy and applauded the College for its progression in the right direction. He further appreciated the efforts towards marks for Library Attendance, Mandation of MOOC, the information resource system at the office of COE as defining steps towards achieving excellence.

Dr. J. Srinivasan, External Expert, suggested the introduction of B.Com. Professional Accounting Degree programme. The Chairman replied, that such a degree programme is not offered by the parent University. Further, he mentioned that the College has an active MOU with Angel Auditors, Tiruchirapalli for Training students for Certified Accounting Technician Course.

Dr. J. Srinivasan, External Expert, suggested that a course on Research and Publication Ethics be offered to M.Phil. Scholars may also be introduced to the PG degree programmes. The Chairman responded that it shall be considered in the next regulation.
