Sub: Aided Colleges – Vaniyambadi, Islamiah College, workload details for the year 1999 – 2000 – Assessment – permission to fill the vacant posts.

As per the G.O. mentioned in reference 1, Aided colleges are permitted to fill 100% vacant posts in the academic year 1999-2000.

As mentioned in Ref.2, the RJDC, Vellore has submitted the workload details received from Islamiah College for the year 1999-2000 and the workload details of the college was assessed. As per the powers vested to DCE by the Tamil Nadu Private Colleges Regulations Rules 1976 Sec.11 (1), the following order is being issued with respect to the sanction of posts for the year 1999-2000. The Director has the power to appoint surplus teachers under redeployment scheme in the presently sanctioned vacant posts. So the college management can fill the vacant posts excluding those posts comes under redeployment scheme.

The above mentioned vacant post of 1999-2000 should be filled up before 31.03.2000 subject to the following conditions.

1. The no. of posts mentioned in serial No.4 and serial No.5 are only temporary. The no. of posts given in serial No.4 has been given by considering that the posts sanctioned in 1998-99 and 1999-2000 have been filled up. Therefore the no. of posts to be filled up and the present no. of teachers should not exceed the numbers given in serial No.3.
2. On any circumstances the no. of teachers should not exceed the sanctioned strength mentioned in serial No.3. Grant will not be given if there is any surplus teacher.
3. During the appointment, G.O.No.111 and 113 of Higher Education dated 24.03.1999 are to be strictly followed.
4. In the case of non-minority institutions, appointments are to be made by getting the list from Employment Exchanges by following roster system.

5. The RJDC should register in its office Register the details of sanctioned post by subject wise.
6. A separate order transferring to other colleges issued for the surplus teachers under redeployment scheme mentioned in serial No.6.
