2.2 - Catering to Student Diversity

2.2.1 - The institution assesses students' learning levels and organises special programmes for both slow and advanced learners.

The learning levels of students are assessed by the teachers of respective subjects in the very first month of admission through interaction with them during lectures, practicals and class room activities. The performance of the students in the first Continuous Internal Assessment Test (CIA I) helps us to confirm the step taken. Since the students are mostly from rural background and there is a great challenge in the form of lack of communication skills in those students and hence, the Department of English conducts Bridge Course for the first year UG students regularly.

Special remedial coaching classes, tutorials and assignments are arranged for slow learners. Advanced learners are given special assignments and are encouraged to appear for examinations like SET/SLET/NET/TNPSC etc. They are also guided to participate in intercollegiate competitions, seminars, conferences, symposiums etc. Arrangements are also made for study tours and visits to Research Institutes, National Laboratories and Industries for Experiential Learning.

2.3 - Teaching- Learning Process

2.3.1 - Student-centric methods such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences:

The college is equipped with ICT Classrooms, Smart/ Multimedia Classrooms, Digital & Virtual Library, Language Lab, Computer Labs and Science Laboratories to focus on Student Centric Teaching and Learning and to have Student Centric Learning Environment. The college has adopted several learner centric teaching- learning pedagogies to create a better learning environment.

Teaching-learning process has been enhanced through interactive mode of communication in classroom teaching. Demonstration methods, use of audio visual aids/ teaching kits and ICT enabled teaching are part of teaching methodology. Faculty use e-learning platforms and e-resources to facilitate student-centric learning. Digital Library and Virtual Library are used to facilitate students to enrich their knowledge by listening to Video Lectures of Resource Persons of National and International Repute. Students are also provided with experiential learning opportunities such as problem-solving activities, case studies, assignments and projects. Experiments conducted in laboratories and practical classes sensitize students towards practical utility of their knowledge. Research-based projects, short projects etc., develop problem solving abilities. Besides classroom teaching, students are allowed to take part in study tours, field visits, industrial visits and internships. Students are motivated to attend seminars and workshops and also competitions are organized for making the

It has become so common in the college that each and every student of the college gets exposed to such versatile experience quite frequently. It is made possible with the availability of ICT tools and resources such as LED Monitor, Overhead Projector, LCD Projector, Tablet, IPOD, Network Lab, Smart Board, Audio/Video/CD Players etc. Students also have the opportunity to access to e-books, e-journals etc. in the library. They can also listen to Audio-Visual Lectures/YouTube Lectures of Prominent Personalities/Lecturers of National or International Repute in the Audio Visual Library and Virtual Library where special provisions are made to such facilities. Students and teachers are encouraged to enrol in Online Courses of MOOCs, NPTEL etc.

Due to the outbreak of Covid-19 pandemic, all the teaching staff members of the college have used various online platforms for effective teaching and learning. Various online tools/resources were used for effective teaching and learning including Google Classroom, Google Meet, Zoom, etc. All the teaching staff members have developed umpteen number of YouTube Videos for their topics/courses of interest.

Islamiah College (Autonomous) has 11 Research Centres offering Ph.D. programmes in different disciplines. Major Science Research Centres of the college viz., Physics, Chemistry, Biochemistry and Biotechnology have separate Research Labs. Apart from these Labs, DST-FIST Lab is also utilized for research purpose. Biochemistry Lab was renovated very recently with all modern facilities. The facilities in these Research Labs are upgraded periodically. Each of these labs has sophisticated instruments for research. The College has well defined policy for promotion of research which is available on the website. One of the most significant initiatives of the college to promote research is Staff Members, especially from the Self-Finance Stream, are given fee concession to do Ph.D., and also the college gives seed money for researchers.

All the Research Departments have separate labs for Research. All Science Departments have at least Two Major Science Laboratories for Experiments and Innovations apart from the DST-FIST Labs. All Laboratories are equipped with costly, latest and high-end equipments for teaching, learning and research. Separate rooms and offices are provided to NCC, NSS, IQAC, Canteen, Book House, Bank etc. The Academic Block consists of Classrooms, several ICT enabled Classrooms, Department wise Staff Rooms, Seminar Halls, 12 Science Laboratories, Computer Labs with more than 380 Systems, Language Lab and well built Auditorium.

The Principal is the academic and administrative head of the institution. He has delegated the powers to the Heads of

The Vaniyambadi Muslim Educational Society, the management of the college, is the Registered Society under the Societies Registration Act XXI 1860. It has its own President, Vice President, General Secretary and Executive Committee consisting of 60 Members.

They are all elected by the General Body members of the Society once in three years. The College Committee comprises Secretary & Correspondent of the college and 14 members who are the Office Bearers of the Society. The Principal is the Ex-Officio member of the Committee.

As Islamiah College is an aided Minority Institutions governed by the Tamilnadu Private College Regulation Act and Rules, 1976, all appointments, service rules and procedures are followed as per the provisions of the Act. Accordingly, the College Committee is the competent authority for all appointments both teaching and non teaching and governance in accordance with the rules and regulations of UGC/State Government from time to time. The College Committee is constituted once in three years and it is answerable to the Executive Committee and the General Body for all its omissions and commissions.

Islamiah College follows the UGC prescribed guidelines for appointing its Staff. It also follows the guidelines of government and other regulatory bodies. All the policies of the Government and Other Statutory Authorities are implemented as soon as it comes into effect. Employees' Promotion, Earned Leave, Medical Leave, On Other Duty, Leave on Private Affairs, etc., are all given on the basis of the Service Rules of Tamil Nadu Government. The code of conduct for both teaching and non teaching staff, as posted on our college website, is strictly adhered to.

6.3.1 - The institution has effective welfare measures for teaching and non-teaching staff and avenues for their career development/progression

The college provides Interest Free Loans to both Teaching and Non Teaching Staff especially to the Management Staff Members. Any emergency need for Personal Loan is addressed by the College by sanctioning them Interest Free Loan which is repayable in EMIs. All staff members are eligible for Festival Advance of Rs 5,000/-to Rs 10,000/- repayable in EMIs without interest. During the Financial Year 2020-21, an amount of Rs 2,25,000/- hasbeen disbursed to Teaching and Non Teaching Staff as Festival Advances and Personal Loans.

The college provides fee concession, for staff pursuing Ph.D., ranging from Rs 5000/- to 10000/- per annum to the maximum of three years. During the Financial Year 2020-21, the total concession in Ph.D. Fees given by the College was Rs 75000. The

At Islamiah College (Autonomous), both Internal and External Financial Audit go hand in hand. Although the External Financial Audit is mandatory, our College duly follows Internal Financial Audit also regularly. Internal Financial Auditor is appointed by the management to oversee the financial transactions and review them periodically. Internal audit procedure is carried out for all academic/non academic departments irrespective of the nature and size of events/programmes. The college has successfully implemented Public Financial Management System (PFMS) from the academic year 2019-20. There are two types of external financial audit viz., (1) Annual Government Audit of our Accounts carried out periodically and systematically by the Office of the Joint Director of the Collegiate Education, Vellore and once in three years by the Accountant General Office (AG), Chennai. It is to be recorded here that no Audit Objection is pending so far with the college. (2) The management of the college has constituted a separate committee called 'Accounts Audit Committee' comprising Senior Auditors and Accountants whose responsibility is to scrutinise all bills and vouchers and audit the accounts of the college every year. The audit financial report prepared by the committee has to be submitted to the Executive Committee of the society periodically and to the General Body annually for approval, as per the statutory provisions of the Societies Registration Act of 1860 and 1976 and this is communicated to the Registrar of Societies, Vellore, every year.

The college is a Government Aided Minority Institution and the salaries of the aided staff are paid by the Government of Tamil Nadu through the Regional Joint Director of Collegiate Education, Vellore. The salary of selffinancing staff is met from the fees collected from the students of self-financing courses. The students of the college are supported by arranging various scholarships from the State and Central Governments such as BC/SC/ST/Minority/Post-Matric Scholarships to help the socially and economically backward sections. Apart from the Government sources, the Management evinces keen interest in mobilising and utilising funds for various purposes. The Management of Islamiah College is generous in spending for Infrastructural, Academic and Physical Facilities. In addition to the Central and State Government Scholarship to the students, Islamiah College also provides Students' Aid Fund to deserving students and also arranges for Scholarships from NGOs. The College sources its funds from the contributions of Alumni.

The management has a separate Accounts and Audit Committee to monitor the proper and effective utilisation of funds in the college. The Principal and the College Committee are mainly

Solid Waste Management

Swachh Bharat Abhiyan has been adopted as a part of clean campus initiative. Trash bins have been fixed in the campus and sanitary workers have been employed for maintaining cleanliness. Biodegradable and non biodegradable wastes are segregated before disposal. Policy of reduce, reuse, recycle has been adopted. Sensitization programmes on water conservation are conducted for students.

Liquid Waste Management

The wastewater from science laboratories are filtered to remove the suspended particles and collected in the sewage tank. COD and BOD are maintained within the permissible level. The pH level is neutralized with alum and lime. The water is passed through RO plant to bring down the TDS. The discharge water is sent to another tank for natural evaporation. The sewage sledge is taken outside for disposal. Organic wastes are transformed into vermicompost. Burning of waste is banned within campus.

e-Waste Management

e-waste generated are collected and transferred for scrapping/recycling to the local vendors on monthly basis. Students are educated to dispose unwanted, unused and broken electronic items according to standard procedures.

e-wastes (Computers and its accessories etc.) are handed over to Tritech Systems, Chennai, an authorized e-waste dealer by the Tamil Nadu State Pollution Control Board, Chennai.
